

PROGRAM MANAGER REPORT

Programs

Meetings:

1. Program Manager met with the Mayor of Bloomington on December 13, 1999. The Program Manager presented current CONA projects and programs.

Benchmarks

1. Operations and Finance

January 2000, Recruit 2-3 part time volunteers.
 The program manager has worked with one IU volunteer on the community mediation training.

b. January 2000, Collection of membership donations.

2. Problem Resolution

January 2000: Establish Investigation Committee.

The program manager will convene a meeting of volunteers who signed up to join what will be renamed: Community Planning Committee by January 15, 2000. Six volunteers have already signed up for this committee.

3. Training and Education:

a. January 2000: operating website.

The website is up. Is there anyone willing to work on the website?

b. January 2000: Sponsor Trainings every quarter:

The initial training was the Long Range Community Planning Workshop. The second training will be the community mediation training.

CONA PROJECTS

Community:

- 1. Partner with HAND, and Bloomington Chamber of Commerce for, "Blooms in Bloomington," distributing bulbs to neighborhood and city locations for beautification. "Program will be inaugurated in April 2000.
- 2. Partner with HAND and Indiana University in Neighborhood Initiative Project. This project sets up IU resident Halls with a neighborhood association. Program inaugurated on November 6, 1999.
- 3. CONA facilitated a panel discussion, "Creative Approaches to Resolving Conflict." Representatives from various conflict resolution programs presented various methodological approaches to mediation. CONA offered a presentation in the area of community based grass roots mediations. Program was held on November 9, 1999.
- 4. CONA is convening a commission to explore options for dealing with off-campus student issues and neighborhood residents. CONA has received a commitment from the IU Dean of Students' office to write letters for off-campus residents. The Dean of Students' office will also send a representative to all commission meetings. The commission will include a representative from off-campus student government, neighborhoods, landlord associations and IU.

Organizational:

- 1. CONA has initiated the formation of an Advocacy Committee. The Committee has met and decided that the first priority for community advocacy is to establish better communication between city departments and neighborhood associations. Members of the advocacy committee are now drafting a "Community Guide for Neighborhood Associations."
- 2. CONA has initiated a Community Planning Committee. The first efforts towards working on community planning were the "Long Range Community Planning Workshop" held on December 9, 1999. Over 10 neighborhood association representatives attended the workshop. The workshop was co-sponsored by the City of Bloomington Planning Department. CONA has produced, "A Neighborhood Association's Guide to the Growth Policies Plan Update 2000." The Guide includes a projected timeline of the updating process and action steps for neighborhood associations.
- 3. CONA is sponsoring a 3-hour introductory training session on February 5, 2000 in community-based mediation.
