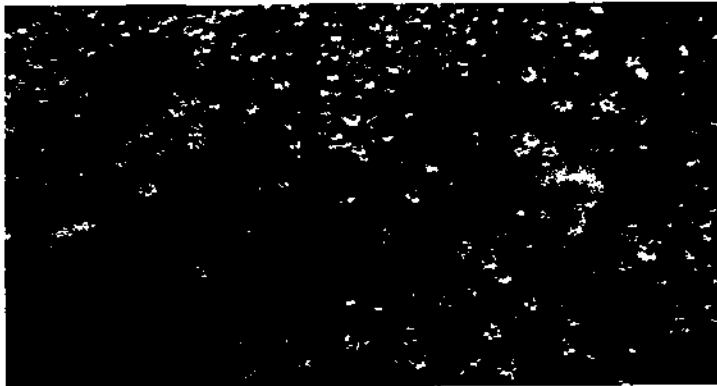

McDoel Gardens has been involved in a Neighborhood Plan in conjunction with The Bloomington Planning Department and HAND. The purpose of such a plan is to set out and define goals for the neighborhood. The process began with an inventory of the neighborhood which identified the strengths and potential threats; the best of the neighborhood and what needed improvement. Committees involv-

ing neighbors, city officials and other stakeholders in the neighborhood have met in a series of meetings during which this information is being translated into specific goals, timelines, and possible ways to accomplish the desired item. After the completion of McDoel's Plan, another neighborhood will be chosen for the same process.

In the meantime, Eastside Neighborhood Association did a little envisioning of their neighborhood in their May meeting. Guest Phil Stafford shared with them the experience of "seeing" your neighborhood in a different way. He talked with them about the benefits of children and the elderly working together. ## CONA — New Officers — annual meeting

At the June meeting of the Board of Directors, a by-laws change was made restructuring the leadership of CONA. Instead of electing a president, vice-president, secretary, and treasurer, the Board will elect an Executive Committee that has been nominated by a nominating committee. Persons accepting these nominations agree that they will fulfill whatever role is needed to be filled. All the functions of the various traditional offices will still be carried out but the same person may not be carrying out those same duties for the next two years. It is hoped

that this arrangement will give more flexibility in handling unforeseen circumstances that may come up. It may also allow a person to lead in areas best suited for them and their leadership strengths. The executive committee elected for 2002-2203 are: Kathy Holland, Elm Heights; Teri Inskip, Waterman; Jim Opiat, Bryan Park; Bill Sturbaum, Prospect Hill; and Dave Walter, 6th and Ritter. The CONA annual meeting will be held at the September Board of Directors Meeting. According to the by-laws, the president (executive committee) shall summarize

the results of any current matters and shall propose to the Board of Directors the general program of activities that is planned for the then current year. The program proposal together with the general outlines of the financial plan for the current year shall then be voted upon by the Board of Directors.

## Blooming Neighborhoods Celebration



The Blooming Neighborhoods Celebration held on May 11 at the Farmers' Market was a great success. Several neighborhoods in addition to CONA and HAND had display tables that were visited by many shoppers at the Market.

Awards presented to neighborhoods by the City were The Mayor's Excellence Award — Arden Place Neighborhood Association; the City Council's Neighborhood Enhancement Award — Waterman Neighborhood As-

sociation and the HAND Neighbor of the Year — Dave Ebeling of Arden Place. All winning neighborhood associations received \$100 for their accomplishments.

CONA presented certificates of appreciation to neighborhood associations and to individual residents of some neighborhoods for their In-kind contributions of time spent on behalf of neighborhoods in our community. In just four months, more than 3300 hours of time was re-

ported to CONA.

In-kind contributions, both of time and service, are important to the life of a non-profit. Neighborhood associations should continue to report hours spent so that next year we can report an entire year's worth of volunteer time. Do not forget to let CONA know your volunteer time. Make sure you report when your association meets and the number of people in attendance. ALL our neighborhoods need to be recognized next year.

## County Neighborhood Associations

CONA Program Manager met with officials from the County Planning Department to talk about neighborhood associations. The County Planners are now in the process of developing plans for the Ellettsville area and the Harrodsburg area.

The Program Manager attended an Ellettsville Plan ses-

sion on May 29. CONA's purpose was to present information about the strengths of neighborhood associations from several perspectives.

CONA has a countywide mission involving neighborhood associations. The involvement of county neighborhoods will be an asset to all. Many decisions of county gov-

ernment affect city residents and conversely for city decisions and their impact on county residents. We may be in need of city neighborhoods to serve as mentors for a short while. 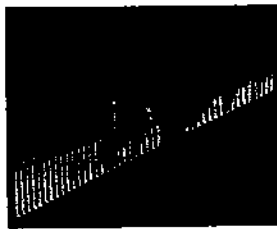
