- 1. Minutes of the February 21, 2001 meeting were approved.
- 2. Treasurer's Report: Jan Bulla-Baker reported that the current checking balance is \$2,022.62 with \$2527.81 in savings.
- 3. Chris Koscica was introduced by Bill Boese. Chris will attend the April meeting and speak about Positive Youth Development as sponsored by the Youth Services Bureau of Monroe County.
- 4. Bill Boese introduced our guest speaker, Sergeant Scott Oldham. Sergeant Oldham passed out copies of summaries of police reports for the past year, noting that there has been an increase in calls and incidents. There has been a big decrease in loud noise complaints because now there is no warning before arrests are made. This has resulted in very few repeat offenders of the noise ordinance. The BPD is targeting traffic stops for speeding in several areas of the city. They now have more officers on the road and can work more hours overall.
- Phil Worthington reported that the Off Campus Issues Committee meeting had three City Council members attend. He believes that City Council is interested; that our concerns are worthy. He now needs involvement and answers from IU.
- 6. The Planning Committee reported that the McDoel Gardens conservation district passed City Council approval. Now enforcement of the ordinance is up to the neighborhood. Other concerns are the Menard's store sewer connection, Melrose Apartments at the old ST Semi-con site and road widening plans for W. 2nd Street from Wal-Mart to College as well as a new extension of Hillside to Rogers Street.
- Bill Boese asked the Directors for a resolution to support the concerns of the Matlock Heights/Blue Ridge neighborhoods about speeding on Dunn Street. It was resolved that a letter of support would be written.
- 8. David Walter reported on the progress of the WEB page. A committee has been meeting with IU students to revise and create a new WEB page. The students now have some of the pages up and running. They are now filling in

the Web site with text and photographs.

- 9. Nancy Lumbley requested that a committee be set up to revise the by-laws. David Walter, Bill Hayden and Elsa Harik volunteered to be on the committee.
- 10. Vicki Provine reminded the Directors that the Neighborhood Improvement Grant workshops were coming up.
- 11. David Walter reported that there will be workshops on basic home repairs for historic buildings to be held at 324 S. Henderson Street in April. He will have additional information to hand out at the next meeting.

There being no further business, the meeting adjourned at 8:40 PM.
