21st Century Challenge: Eliminating Substandard Housing

Habitat for Humanity International challenges communities to eliminate substandard housing in their area, and to set a date to meet the challenge no more than 20 years away. All over the U.S., communities are accepting the challenge to build with a definite plan and at a rate at which it is possible to end substandard housing. Where the need for adequate housing is especially daunting, the 20-year goal may be for a significant, quantifiable reduction in substandard housing.

Locally, the Housing Network has taken up this challenge for Bloomington and CONA has endorsed this program.



Bill Sturbaum serves on the Housing Network Steering Committee representing CONA. They have, thus far, based on exterior appearance, identified 368 "substandard" housing units.

How does the 21st Challenge work?

"We have the know-how in the world to house everyone. We have the resources in the world to house everyone. All that's missing is the WILL to do it." Millerd Fuller, Founder of Habitat for Humanity Local affiliates and Habitat's 21st Century Challenge staff work together to:

- o define the local housing problem
- ° organize a properly constituted local initiative
- °set a realistic date for solving the problem
- o involve the community in the effort
- odevelop a work plan and a budget
- o develop the resources money, people, goods and services — to accomplish the goal.

Growth Policies Plan Update

Neighborhood Improvements

The Sixth and Ritter Neighborhood Association applauds the award for contracts for sewer work and new storm drainage work on West Sixth Street. The Utilities and HAND departments have jointly funded this project. The sewer work will replace a broken main line that has caused backup of raw sewage into several neighbors' homes. The storm drainage work will improve the flow of storm water from the retention pond into the open

ditch by Kleindorfer's Hardware store. Along with this work, new curbs and a sidewalk will be constructed on West Sixth Street, starting at the intersection of Ritter Street and going west to Hopewell Street. The sidewalk will form the top of a culvert that will handle the storm water. It is hoped that this will ease the problem of flooding at this intersection and the lots nearby.

Two new homes will be constructed in the 1400 block of West Sixth Street by Gene Moncel.. The homes have been granted tax abatement by the City Council. Moncel has agreed to rent the homes to low income families at a rate fixed by HUD for the next 30 years. The lots have been vacant for many years and the neighborhood welcomes these investments.

Ongoing Projects/Programs/Grants

A reminder from CONA that several programs have been offered to our neighborhoods in the past months and we need to keep those in mind as we make plans and create visions for our neighborhoods.

*Neighborhood Watch Program - this program allows neighborhoods working with local police officials to address the particular safety concerns your neighborhood has and how neighbors can help. Reports of local vandalism are in the news so perhaps a revisit to that program might be appropriate. Remember, CONA has funds for signage, educational materials, etc.

*Disaster Resistant Neighborhoods --This program, directed by the American Red Cross, is one that neighborhoods might find very useful. Every neighborhood needs to make some assessment about the preparedness we have for any kind of a disaster. To learn more about the program, visit the CONA website, www.conaonline.org (under PRO-GRAMS) Read about the program and look at the checklist for neighborhood safety and personal home safety. All of us have become greatly sensitized to the concept of safety and what it means we

*Neighborhood Improvement Grants -HAND has made available information about its improvement grants (\$2000 minimum) and applications are now available. Also available from HAND is a new grant for smaller projects called Small and Simple Projects Fund which funds projects of \$1000 or less.

Neighborhood organizations can apply once per year for the fund. The first round deadline is January 21. The apps will be rated on project quality, neighborhood participation, neighborhood match, and community benefit. The match is a \$1 to \$1 match. However, the match package can include volunteer labor, donated professional services or skilled labor, and donated materials or supplies.

National Issues Forum (continued)

Begun in 1982, NIF is rooted in the simple notion that people need to come together to talk - to deliberate - about common problems. Indeed, democracy requires an ongoing deliberative dialogue. Forums offer citizens the opportunity to inform themselves on the issues and weigh alternative courses of action. They may help set directions for government.

And, more importantly, they are opportunities for people to talk about common problems. Everyone has a voice in these conversations which encourage a full exchange of views on the issues as well as an understanding and appreciation of differing viewpoints.

The topic selected for the first community conversation is "growth and community wellbeing". This topic was chosen because it is often a polarizing topic in our community.

In a democracy, citizens must come together to find answers that they can all live with - while acknowledging that individuals have differing opinions. Forums help people find the areas where their interests and goals overlap. This allows a public voice to emerge that can give direction to


